SBF 2018 was the most important economic event in the region!

The 9th Sarajevo Business Forum (SBF) was held on the 25th and 26th of April 2018. Bosna Bank International (BBI) CEO Amer Bukvić and the President of the Islamic Development Bank Group (IDB) H.E. Bandar M. H. Hajjar officially opened

"We are proud to have a record number of participants, with 1,800 of them coming from 50 countries. SBF was held under the motto "One Region, One Economy" and attended by many regional leaders. We want to use the Sarajevo Business Forum to show that we have an excellent region with huge potential. At the same time, we want to confirm that cooperation between the governments and the private sector, or private-public partnership, is a possible way forward in the region and the world," Mr. Bukvić said.

With a number of program panels and roundtables, the focus was on the economic integration of the region and cooperation with countries of the European Union.

Participants had an opportunity to hear differing and relevant opinions regarding the most important economic and development issues which involve cooperation in the region as well connections with the Asian economic space. The number of B2B meetings at SBF confirms that the 9th SBF was one of the most successful.

As in previous editions, Sarajevo Business Forum was recognized by the highest BiH, regional and European political officials. Among others, BiH Presidency Chairman H.E. Bakir Izetbegović, President of the Republic of Slovenia H.E. Borut

Pahor, Chairman of the Council of Ministers of Bosnia and Herzegovina H.E. Dr. Denis Zvizdić, Deputy Prime Minister of Republic of Turkey H.E. Mehmet Şimşek, Deputy Prime Minister of Republic of Serbia H.E. Rasim Ljajić showed their support for regional cooperation and development.

The significance of SBF for the development of the region was recognized by the Governor of the Saudi Arabian General Investment Authority (SAGIA) H.E. Eng. Ibrahim Al Omar, Vice President of the Parliament of Montenegro H.E. Branimir Gvozdenović, Former President of Croatia H.E. Stjepan Mesić as well as by many other political and business representatives from the world and the region. In support of the efforts regional countries undertake to improve their economies and become

equal partners in economic exchange with EU member states, SBF was also attended by Dr. h.c. Doris Pack, President the European People's Party and Former President of the European Parliament's Delegation for the Southeastern Europe.

Expressing interest in cooperation and investment in the region, the invitation of the organizers was accepted by the delegation from Indonesia, headed by Minister of Land and Spatial Planning, H.E. Sofyan A. Djalil, as well as by representatives from European countries, the USA, Bahrain, the United Arab Emirates, Saudi Arabia, Malaysia, Turkey, Japan, Pakistan and others. Key Points Changing the region's image Sarajevo Business Forum hosted 1,800 participants, including 371 accredited media outlets from more than 50 countries. SBF comprised three separate events: a welcome reception in City Hall; the Forum's first day in the Parliamentary Assembly of Bosnia and Herzegovina; and a second day in Hotel Hills. Day 2 included panels about tourism, the diaspora, and what people of Southeast Europe can do for the region. There was a general consensus that the region should connect with Asia. Day 2 also featured business meetings and created a common action platform. There were 365 meetings, an increase of 15 percent from 2017. The organizers announced that 2019 would mark a jubilee edition of the Forum to celebrate its tenth year. Mr. Amer Bukvić, CEO of BBI Bank reiterated his appreciation for the support of the government, co-organizers, sponsors, media, private sector, chambers of commerce, organizing staff, and others. With the help of many contributors, the Forum's organizers felt they had

This is our Forum's 9th consecutive year, and we could not be more proud to have so many respected guests.

SBF is unrecognizable without the support of BBI's shareholders the Islamic Development Bank, Abu Dhabi Islamic Bank and Dubai Islamic Bank. Their support and guidance continues to be much appreciated.

Sarajevo Gateway to Region / RCC

I am very glad that Sarajevo Business Forum has developed itself into the gateway for foreign direct investment in Southeast Europe. We contribute to regional integration together with the Regional Cooperation Council, an institution supported by the European Commission.

I am encouraged to see continued improvement in most macroeconomic indicators of the region, especially in the long-term. FDI has improved significantly in countries of the region. Unemployment rates continue to fall. Events like SBF, which promote Southeast Europe as a unique investment destination and create a platform for starting new businesses, can reverse the effects of brain drain on the economy. This region possesses all the prerequisites and talents to generate growth - if energies are focused on mutual cooperation and maintaining stability.

Exports of goods and services from the region are growing faster than imports, resulting in a declining trade deficit. Consider the year 2010 when this conference was established. Exports outpaced imports by 44%. By 2017, this figure grew to 60%. These trends are similar to other countries. Being close to the EU opens huge possibilities for companies from SEE to be part of supply chains for large EU producers.

There are other promising trends. The number of registered foreign tourist stays in Bosnia tripled since Sarajevo Business

Forum was first organized. The average annual growth of foreign tourist stays in the country was 14% in the past eight years. This remarkable statistic elevates Bosnia into one of the world's fastest growing tourist destinations. Other Southeast European countries have experienced similar results.

Significant impact

Leadership indeed has a significant impact on performance across all levels within any organization. Any organization or country aspiring to meet its full potential cannot afford managerial shortcomings or a lack of vision. Today, during our session on Women's Leadership, we want to encourage women to get more involved in leadership roles because women are an important factor for positive changes in any society.

Economic prosperity is a prerequisite for political stability, and this makes SBF's impact on Southeast Europe's future even stronger. Results of past Forums have included investments in tourism, agriculture and industry in the region and established increasingly-frequent flights between the Southeast Europe and the Middle East and Asia. A plan to reestablish direct flights among regional airports could build on these successes. It is important to note that Southeast Europe's GDP growth projections are stable and are expected to be above the EU's average growth rate. This is another reason why investing in the region is worthwhile.

I invite all participants to unite in the same goal of strengthening cooperation and benefitting from the comparative advantages of each country for the sake of a better future in Southeast Europe and the world.

Together, we can strengthen this region, create success for our international partners, and give the next generation an opportunity to build a better and brighter future. ■

Economic growth is the best route out of poverty

It is a great honour for me and for the IDB Group to join this august gathering at the opening of the Sarajevo Business Forum in its ninth edition in 2018. This is my second consecutive participation in this Forum in my capacity as the President of the IDB Group. The quality of organisation that I have noticed this time makes me affirm that the Forum has become the largest and most important business event in the region.

I am pleased to mention that the distinguished partnership between the Republic of Bosnia and Herzegovina and IDB is not born in this event but has been ongoing for several years. In particular, I including the promulgation of the laws and regulations required to provide a conducive investment climate. The IDB Group will continue to support these reform measures.

Developing countries

Let me emphasize that the governments of developing countries alone cannot address the development challenges that they are currently facing. I will highlight two crucial and emerging challenges facing our member countries, namely the alarming level of national debt and their budget deficits.



would like to highlight that IDB is a founding partner of Bosna Bank International (BBI). IDB also has the honour to contribute to several projects in Bosnia and Herzegovina, such as facilitating the BBI lines of financing for Bosnian farmers, waqf projects and scholarship programmes benefiting 64 students in engineering, medicine and pharmacy, of whom 46 have already graduated.

Economic Reform Programme

We are happy to observe that Bosnia and Herzegovina is an upper middle-income country with great accomplishments since the mid-1990s. It has now embarked on the Economic Reform Programme (ERP) 2017-2019, which sets a medium-term macroeconomic and fiscal policy framework that includes a comprehensive programme of structural reforms aimed at boosting growth and competitiveness of the country. Authorities are determined to reduce the large size of the public sector and are creating favourable conditions for a larger – and internationally competitive – private sector through a business-friendly environment that is conducive to both local and foreign private investment and shifting focus from consumption-based economic growth to the production of goods and services. Recently, we have seen the fruits of several measures and reforms implemented by the government towards promoting investment,

Therefore, I urge governments to adopt different development models by rationalizing their financial and fiscal policies and strategies to reduce their budget deficit, which is the mother of most economic problems, and make their debt sustainable. At the same time, IDB is trying to adopt a different development model, transforming it from a 'development bank' to a 'bank for development and developers' by involving the government, private sector, NGOs, civil society, philanthropic institutions, universities, and research centres. IDB's role would be bringing development partners to work together and defining the role of each partner. Hence, IDB's role would be a facilitator and coordinator, participating in financing, capacity building, supporting the development of laws, overcoming obstacles, and working with all partners in a collective and collaborative manner, rather than an individual one.

We believe nurturing economic growth is the best route out of poverty here in Bosnia and Herzegovina and across our member countries. Science, technology and innovation offer more solutions than ever before, and there has never been a greater need for those solutions to tackle the world's developmental challenges. We believe that if you give people the tools to build a sustainable future for themselves, their communities and their countries, you will build up their pride and enable them to fulfil their potential.

Despite problems, Bosnia and Herzegovina is moving forward

Thanks to, among others, the agile BBI Bank team, Bosnia and Herzegovina and its capital have become an attractive place for investors from all over the world over the past nine years.

A testament to this year's Forum is a wide range of participants who want to work with Bosnian businessmen, start their businesses in Bosnia or invest in the jobs that are offered to them. Bosnia is a perfect place for connecting businessmen from the East and West. Testament to this are large infrastructure projects that are being announced. Bosnia and Herzegovina offers great investment opportunities to all businessmen right here at SBF. I

want to remind you that this country is rich in water and that this enormous potential is still modestly utilized. Water bottling or the country's hydro-electric potential for the production of electricity are an opportunity for investment. In addition, Bosnia is exceptionally rich in coal, forests, strong winds and numerous types of minerals. We also have significant amounts of oil, and these sites should be explored and prepared for exploitation. The country also offers many other benefits, such as its long industrial tradition, its educated and disciplined workforce, a stable Euro-linked currency, the same rights for foreign and domestic investors, companies with a long and rich tradition in international trade and business etc.

Over the past nine years during which SBF has been organized, the situation in Bosnia and Herzegovina has considerably changed for better. This, in particular, refers to the past three or four years during which the state and entity governments have initiated comprehensive reforms that will ultimately result in more efficient administration, higher financial discipline in the market and a generally better and more secure business environment. A significant portion of these reforms have already been implemented and, despite the complicated constitutional and legal arrangements and occasional political crises, it has yielded significant results. The number of employees over the last three years has increased by about 50,000, unemployment has been steadily declining, GDP is growing within the projected frameworks, and we have recorded a strong increase in exports and a reduction in public spending.

All of the government's important funds are stable; the state and the Federation of Bosnia and Herzegovina can function without IMF loans that we previously relied on. Through direct and indirect taxes, several billion more KM were collected compared to previous years. This is a direct reflection of a strengthening economy. Based on these important economic parameters, we are following in the footsteps of neighboring countries. According to the growth of exports and the fall of the unemployment rate, we are a leading country in the region, just as we are in terms of the number of tourist visits. Yet we still expect a major development and infrastructure boom. All preconditions have been met, the financial plan related to the construction of the highway on corridor 5C is practically finalized, and this will serve as the transport backbone of Bosnia and Herzegovina. We also expect to accelerate the construction of expressways that will ultimately connect all major centers with Sarajevo. Also, in cooperation with Serbia and with the help of a friendly Republic of Turkey, we are starting to prepare for the implementation of a major project: The Sarajevo - Belgrade Highway.

In addition, we want to build an airport in Bihać in our beautiful Krajina, which many call paradise on earth because of its natural beauty. There are also a number of other energy infrastructure projects that will be discussed in more detail at the Forum itself and during bilateral meetings. Despite major improvements, we cannot yet say that the situation in this country is great, but we can say that it improved and that it is stable. We are doing our best to stop young people from leaving for EU countries, which is a problem that does not affect only Bosnians, but rather the region as a whole. Despite numerous problems, Bosnia is moving forward slowly, but at least it is moving.

This year's Forum is an opportunity in which the friends of our country, who have done wonders in their countries, will help us do the same or a similar thing here. It will be to our benefit.



H.E. Borut Pahor, President of the Republic of Slovenia

BiH has a great friend in Slovenia

Slovenia supports Bosnia and Herzegovina and other countries of the Western Balkans in their efforts to become members of the EU and NATO. We are ready to share our experiences and knowledge in order for these countries, including BiH, to become EU and NATO members as soon as possible, if that is their decision.

After the global economic crisis in 2008, the EU hesitated with expansion; that is, the progressive enlargement process in the EU was stopped. But now, after five years, the general recovery of the European and global economy and interest in this region has revived political will for the EU enlargement process, which I strongly support. I believe it is a mistake if the European Commission does not regard the process of enlargement of the Union in the Western Balkans as a political process (what it actually is) but considers it a technical process (which it is not); this will prove particularly difficult in the case of BiH. The BiH state regulation is special and, in my opinion, demands a very cautious political approach to the European Union. I am committed to such an approach. After Croatia became a member, and with the expected accession of Serbia, it is hard to imagine that BiH will remain outside the EU for a long.

The most important thing is that countries of the Western Balkans themselves ensure the credibility of the reform process, in particular by implementing reforms to strengthen the rule of law, aligning legislation with EU legislation and building the institutions necessary for general progress. Regional cooperation remains the most important tool for promoting reconciliation and prosperity.

Although the Slovenian economy is oriented towards the Western market, countries of the Western Balkans are the second most important foreign trade partner of Slovenia.





H.E. Dr. Denis Zvizdić, Chairman of the BiH Council of Ministers

Results achieved in foreign trade confirm improvement



A combination of our natural and human resources, the reforms implemented as part of huge and well-prepared investment projects and our potential, is certainly one of the most successful formulas for attracting foreign investments and economic development in our region. In the past year, the BiH Council of Ministers actively worked on strengthening financial discipline, improving the structure of public expenditures and the business environment, as well as increasing the economy's led to improvement of the main economic parameters in BiH. GDP growth, as well as the growth of industrial production and the processing industry, was recorded, while BiH's public debt was reduced at the same time.

The largest foreign investors in BiH include Austria, Croatia, Germany, Italy, the Netherlands, Slovenia and Serbia. The foreign direct investments, which are particularly encouraging have been recorded in the production sector (more than 40 percent of total FDI) and in the banking sector (about 24 percent of total FDI). Tourism is an economic sector with exceptional potential, and according to the World Tourism Organization, the country has recorded up to a 26 percent increase in tourism over the past few years. If we take into account the given data, we are rightfully expecting to see even more intensive development of this economic branch in BiH. What I would particularly recommend as a great opportunity for investments in BiH are the sectors of energy, tourism, IT industry, metal industry, wood industry, as well as agricultural and food industries. Final negotiations with the World Trade Organization are in progress, and in this respect I expect BiH to finally become a member of the World Trade Organization in 2018. ■

H.E. Mirko Šarović, Minister of Foreign Trade and Economic Relations of BiH

We cannot be competitive with this level of infrastructure development

We will use these two days at the Sarajevo Business Forum for meetings with the heads of delegations from several countries, and the focus will be on the neighboring countries. We will present key potential projects in BiH to the funds, among them the Saudi Investment Fund.

Reactions are positive, and we can send a positive message of regional cooperation, which I strongly support. Development of infrastructure is one of the priorities. BiH and the countries in the region cannot expect to catch up with the European Union countries with a current business climate.



When it comes to investments, we

cannot be competitive with this level of infrastructure development. In addition, stability is the most important idea of this Forum, as well as the change in the priorities of the people who lead the countries.

H.E. Sofyan A. Djalil, Minister of Land and Spatial Planning, Republic of Indonesia

Our relations have made progress

the region have an opportunity to develop cooperation, as well as that we can also better present our culture here.

The key to investing is peace and prosperity

I hope this will help us bring about deeper regional interaction, as well as bring as many investors to this beautiful country as possible. You give us excellent examples of why Turkish firms should invest in BiH. We encourage them to do so, because we believe in the prosperity of this country, which offers great potential for investment. Turkish firms have invested \$ 35 billion abroad last year. We want to strengthen relations with this region


Together we are working on policy changes that will enable us to create a favorable climate for foreign investments. If we refer to the changes introduced by Morocco, we are talking about changes in the economy and the success made in the presentation of several projects that have changed the situation in the field of economy. Thanks to free trade between countries, which also involves Morocco, we want to encourage other countries to get involved in these projects. We managed to implement a large number of projects, especially those related to solar energy. We are working on improving our science and jobs related to employment. Morocco wants and achieves much in the field of attracting foreign investment, and we want to strengthen relations with this region because doing business with BiH is very important. Our trade is at a low level, and we want to strengthen this trade and political relations in the process.

H.E. Rasim Ljajić, Deputy Prime Minister and Minister, Ministry of Trade, Tourism and Telecommunication, Republic of Serbia

Increase export and investments and invest in infrastructure

Over the past 20 years, we had about 70 different regional initiatives whose main goal was to establish at least some degree of political stability following the wartime conflicts, as well as to create something that would become a common market in this area. The result of all these conferences is the CEFTA agreement that really created a free market among the six economies of the Western Balkans. Yet, it seems to me that the list of successes ends here because CEFTA is in a serious crisis today, and, apart from that free market, we got stuck in making progress with economic integration that would lead to creating something we can see in the Baltic or Nordic countries.

There are two reasons why the economic integration of this region was ground to a halt. First of all, there are political reasons, since we are still dealing with the consequences of wars and unresolved matters, ranging from the fact that the borders are not settled to all other issues that objectively make it difficult to establish full political stability in this region. The other reason is purely economic, i.e. with the interest. Today, we have more non-customs barriers among CEFTA members than we have with any other country, and this applies to all of these six economies. We are extremely creative at inventing new obstacles, including the manner in which the trucks carrying the goods will cross borders, so it is not surprising that we do not perform well on all rankings that deal with cross-border trade. The other thing that our economic recovery should be based on is investments. The third thing is investing in infrastructure.

A welcome reception for the participants of the 9th Sarajevo Business Forum was held in City Hall; the Forum's rich three-day program officially started in the BiH Parliament Building. Western Balkans Six Regional Economic Area

Thriving with the European Union

This panel was dedicated to the economies of the six Western Balkan countries and their links with the EU. It also featured a discussion about the problem of a bloated public sector which is fertile ground for corruption. The participants also focused on the importance of the connections between countries in the region and invited investors to invest in these countries.

The panel moderator was Ms. Dragana Djurica, Senior Expert on Competitiveness, Regional Cooperation Council, while panelists included H.E. Mirko Šarović, Deputy Prime Minister/ Minister, Ministry of Foreign Trade and Economic Relations, Bosnia and Herzegovina.



Dr. h.c. Doris Pack, President of European People's Party and Former President of the Delegation for SEE, European Parliament



Politicians should not intervene in business operations, i.e., business itself. You are on the path – you have done a great job on paper – but you need to implement it. We ask you to do it. I keep telling people from Bosnia who are in Germany to go home, and they say that they are not welcome there because they do not have a job, and they are not members of political parties.

H.E. Zdravko Počivalšek, Minister of Economic Development and Technology, Republic of Slovenia



Regional economic integration is very important. In my opinion, the most important thing is strengthening connections and communication. A product made in Macedonia needs three days to reach Slovenia. The region should find solutions for free trade in order to be more competitive. I believe that technology, education and the digital economy can easily overcome state borders,

but the first step is quality cooperation between countries in the region. It is also important to do business with EU member states. From our point of view, it is also rather important to improve the business climate and implement a reasonable tax system and flexible labor laws.

Mr. Zdenko Lucić, Managing Director, Agency for Investments and Competitiveness, Republic of Croatia

As far as investments are concerned, our agency wants to see more export-oriented investments. Few products come to Croatia, and these are mostly shipments. We try to stay aware of both our positive and negative traits in order to be ready to respond to the challenges of the global economy. It's all about how much you invest in the preparation process and how much you



will get from it in return. Our advice to you is to plan for goals and effectively implement those plans in order to succeed in the future by utilizing all benefits offered by a joint-membership market. The biggest challenge is to make young people stay in their own country and increase their standard of living. All countries need to find the best way to solve this global problem.

Mr. Guido Clary, Senior Banker Responsible for Lending Operations in the Western Balkans, European Investment Bank



We are investing money in projects that are in the EU's interest, and we gave about 78 billion euros to the market in 2017. About 90% of our operations take place within the Union. We are the largest financier in the Western Balkans, and our activities follow the EU's goal of assisting Western Balkan countries with accession and fast integration into the EU. We are here to support enlargement prospects while

expecting it to be a process that will be completed fully. As for challenges, as a long-term lender, I must say that it is not enough to reach a higher income status. The challenge is also presented by insufficient regional connections, especially when it comes to transport costs and trade improvements.

Dr. Duško Knežević, Founder and President, Atlas Group, Republic of Montenegro

In the Balkans, tensions are quite dramatic. Ethnic tensions are the biggest problem, and my message to Brussels is that it is better to Europeanize the Balkans than to have the Balkans balkanize Europe. I think that this is a very important message because Brussels must not act in bureaucratic man-



ner. Instead, it should act as a mentor, to be here with us, and Brussels should implement everything that we are doing today. The EU must intervene and help us reduce tensions that prevail among the countries of the region. In my opinion, it is important for the region to establish traffic, remove border barriers and invest more in education and the digital economy. We have extraordinary potential, and we should use it.

Mr. Branimir Muidža, President of Foreign Investment Council, Bosnia and Herzegovina


We really need politicians who will remove barriers and ensure stability in the country so that young people and younger generations will stay in their own countries and build their future. The key message is clear. If you want to remember just one sentence from this Forum, let it be a positive one. No serious investor has lost capital in



this country and this region. Therefore, you can invest freely. We all know what we need to do. We need to lower taxes, have more communication among politicians and create a higher standard of living for people in our countries.

Our government is working towards European prosperity and continental security. These goals are our common objectives in the case of regional countries as well. When we talk about political legacy, we refer to those persistently controversial issues that have been lingering after the 1990s. It is important to strengthen and build good neighborly relations, especially here. Establishing connections is highly important for any success, particularly for investments.

Southeast Europe International Gateways and Connectivity

European vision must be tangible to our citizens





Panelists presented their personal views and suggestions on the best ways to facilitate the EU accession process. The panel's topics included European vision, digitalization, privatization and the influence of the media. Panelists concluded that the European vision must be tangible and visible to its citizens and that the EU must expand while countries in the region maximize their efforts to adopt standards and conditions of the European family.

H.E. Stjepan Mesić, Former President, Republic of Croatia

Europe must work on the EU enlargement process, while regional countries should do their best to adopt the conditions and standards of the European family. Why did Yugoslavia break up in the war? It had been clear that a new political agreement should have reached some new goals.

But the world did not understand the events that could ensue following the break-up of Yugoslavia; there was a brutal war, and we remained engulfed in hatred. We need the help of the EU because it is an elite economic-political project which represents our desire and destiny. I think that it is possible to do a lot more, to have Europe work on EU enlargement. During his campaign, President Donald Trump said several things, and one of them was that America must not destroy existing systems and introduce a new one, that countries should try to reach agreement with Russia instead of opposing it. But he returned to a policy that does not help the cause of the world



peace. The world has moved on, and that is why it is necessary to send a message to political elites that the United Nations needs to be prepared to act in a preventive manner and not when the war is already ongoing. It would be a great message to political elites.

H.E. Valdis Zatlers, Former President, Republic of Latvia



This region can learn from us, because it shares many similarities with us not only between the Balkans and the Baltic States, but also based on the fact that most trade takes place between neighbors. At the same time, we have different types of neighbors. We have Russia, you have Turkey, we have Poland,

you have Bulgaria and Romania, we have Sweden just across the sea, and you have Italy. You have Germany, and we also have Germany as a driving force of the economy. We need to understand that the EU is not a Santa Claus that brings gifts. Politicians should tell people that and motivate them; this is very important. All countries that want to join the EU cannot say "we like this and we do not

H.E. Şekib Avdagiç, President of ITO, TOBB Representative, Republic of Turkey

Turkey's economy is growing rapidly, despite the fact that the country has held a candidate status for years, and it is constantly criticized by Brussels. We have held an EU membership candidate status for a long time now, so we came a long way in terms of candidacy. As a citizen of the Republic of Turkey and a



businessman, I think that, from the point of view of the Balkans and Turkey's vision for the Balkans, the region has not been able to take all the steps it needed. In the sense of its adaptation to the EU and its global policies, Turkey has taken many steps aimed at integration. Now, we are not delighted by the position we find ourselves in. But, our exports have grown six times over the past 15 years.

H.E. Branimir Gvozdenović, Vice President, Parliament of Montenegro



The digital world has introduced us to modernization that unites the region. We in Montenegro found it very helpful to turn to investors. Before the euro, we had 10 million euros worth of investments, followed by one billion euros. We created a great climate while digitization took place in the region. We

want to send a message that we have to work together more and have more support from the European Commission because we need to invest in the infrastructure and digitization of this region.

Mr. Ian Brown, Head of Office, European Bank for Reconstruction and Development, Bosnia and Herzegovina

This region faces considerable challenges. We have to invest in physical infrastructure because it is deficient. The question is how to create a unified economic space in the Western Balkans. We do not even have a single space in Bosnia and Herzegovina. In principle, everything de-



pends on the countries of the region themselves. We need to remove the non-tariff barriers.

Mr. Iztok Mirošić, State Secretary, Ministry of Foreign Affairs, Republic of Slovenia

The Western Balkans is a kind of crossroads between the north and south, west and east, but it's mostly a crossroads between the past and the future. Today, this region is the poorest in Europe, and this is an unfortunate truth. The countries of the region are poorer than the poorest



countries that are members of the EU. This is a consequence of the policies pursued by political elites. We have a new EU enlargement strategy as well as a new narrative, and that is credibility. Structural reforms are important. The EU should also offer credible membership to these countries.

Mr. Mujo Selimović, President of the Supervisory Board, Media Group Oslobođenje/ TV1, BiH

Regarding the perception of potential investors and other people and the way they see Bosnia, I would like to emphasize one fact which is quite unfavorable. These groups often have a negative image of the country, and it often prevents investors from coming here. The reality is actually different. The media



should change these perceptions so that they at least mirror reality. The media can do a lot more than they do now. We need to point out the obstacles, but I still believe that in the case of Bosnia, the media does not have a strong influence on changing political dynamics.





The Role of Women's Leadership in Development

If men don't leave you place at bargaining table, you should bring a folding chair with you



Participants discussed how women lack both systemic support and confidence to develop their business potential and become more influential in a business environment that is challenging and characterized by cultural barriers. The panelists, who encountered these and similar obstacles during their careers, presented their experiences to remind the audience of the growing role of women leaders in economic and societal development.

H.E. Shaikha Mariam Bint Hamad Al Khalifa, Vice President, Bahrain Businesswomen Society, Bahrain

We have to stick together



There are many women in Bahrain who are in leadership positions, and we are always striving toward that. Our government places a lot of hope in successful women and strives to make them as such. Women in Bahrain are successful politicians, medical workers, ministers, lawyers, economists and, finally, mothers. I

know that each of us is different, but we have to stick together in order to achieve something, and I will always be a part of that mission.

H.E. Semiha Borovac, Minister of Human Rights and Refugees of Bosnia and Herzegovina, Bosnia and Herzegovina

You should love your job



I got involved in politics in 1996 when I completed my university education because I wanted to help my homeland. After 22 years, I still think and want the same. For each job, you need understanding, tolerance and love. If you love your work and do it devotedly, there will be no problems; if you stick with this, women can hold any

The EU Supply Chain and its Impact on Western Balkan Companies

Cooperation between regional and EU countries is the key

to economic growth

Panel moderator was Dr. Elma Agić Šabeta, Head of Strategy,



This panel focused on strengthening regional industries by creating stronger supply chains, identifying ways to increase manufacturing of finished products, and identifying advantages that EU neighboring countries can count on. The panel was attended by the representatives of numerous companies in Bosnia and Herzegovina who talked about the pharmaceutical and automotive industries.

Mr. Mirsad Jašarspahić, President, Chamber of Economy of the Federation of Bosnia and Herzegovina

Among the most important sectors are industry and services, and the Chamber is tasked with providing better networking opportunities. Last year, a project for the development of the automotive industry in FBiH was launched. Our project involves opening automotive industry offices in Germany. Therefore, our goal is to



establish cooperation between Bosnian and German companies, such as Volkswagen.

Mr. Umur Gökçe, Policy Analyst, Organisation for Economic Cooperation and Development (OECD)

The Western Balkans has done a great deal in harmonizing laws, but the problem is that small and medium enterprises are not really aware of this, and even when they are aware, they do not know how to take action. Since SMEs are facing problems, our goal is to familiarize them with the standards that make it easier



for them to position themselves in the EU market.

Mr. Martin Gaber, Deputy Director, German Delegation of Economy, Bosnia and Herzegovina



Branch offices of the Delegation of German Economic Affairs are found in 140 cities in 92 countries, including Sarajevo. The Western Balkans is a market with more than 80 million consumers, and we see its future potential, as it is a place of fast-growing economies. In Germany, companies participate in economic surveys and the results show that many of

them would invest in BiH, either for the first time or repeatedly, because this country is a great place for investments.

If we look at the macroeconomic perspective in the medium term, we can see that GDP in Southeastern Europe is growing, and it is expected to reach 3.2 percent. We noted that there is significant progress in all economies of the Western Balkans, including Bosnia and Herzegovina and Macedonia. All Western Balkan countries should follow the example of Croatia and Slovenia.

Mr. Mahmut Galijašević, CEO, MANN+HUMMEL, Bosnia and Herzegovina



There are several reasons why Bosnia and Herzegovina is important for foreign investments, and one of its biggest advantages is that it is situated in the middle of Europe. I am also sure that the country has a strong workforce which we must invest in and develop as much as possible. Bosnia is one of example of how it is possible to do great business. Believe me, the

automotive industry is a serious business. Unlike other Bosnian companies that mainly deal with manufacturing, we also have engineers who create, produce and even test products in their workshops. In Bosnia and Herzegovina, we have capable people and great opportunities to further develop the automotive industry.

Mr. Zlatan Faik Uzunović, Supply Chain Manager for Central and Eastern Europe, Prevent Group, Bosnia and Herzegovina



Customers from the EU demand that they receive a product as soon as possible, particularly with online shopping, and their confidence in EU companies' work is growing. The time needed for one product to be delivered is about 18 months, and one third of it is spent on the supply and delivery of raw materials. Therefore, companies are increasingly moving to this area

to be closer to EU customers and reduce delivery time. Bosnia needs five new Prevent-like companies, and it needs for Prevent itself to be five times larger. ■

Mr. Ekrem Turajlić, Corporate Sales Director, Bosnalijek, Bosnia and Herzegovina

The pharmaceutical industry is well-organized, and even before a product goes to the EU or any other country's market, it has to be reviewed by a regulatory body. This is a competitive industry, and Bosnian producers face a task of delivering quality medicines. Because Bosnalijek is not a part of a corporation, the industry needs to explore markets on its own and



register products, which can sometimes take up to three years Our earlier focus was on the countries of the former USSR and the region, but now we are turning to the EU. I think that they will be satisfied with us because we buy materials and packaging from them; this will ultimately strengthen our relationship.

Mr. Muris Obarčanin. CEO, MDG International, Bosnia and Herzegovina

I represent local entrepreneurs as well as foreign investors because I spent 28 years in the Netherlands. Of the 55 people currently working in my company, everyone is less than 30 years old, and they come from local high schools and universities without previous work experience. We have 25 customers in EU countries as well as rich experiences with



start-up companies. We have great opportunities, and I can freely say that many companies are standing in line to access the Bosnian market. The interest of foreign companies has increased over the past two years, which means that the trust they have in our market is growing.

Ms. Karin Hörhan, Programme Manager, Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH, Germany

In Bosnia and the region, we support small and medium enterprises because they account for 90% of a country's economy. What we tell them, especially small businesses, is that their only chance to succeed in the global market is by working together. In addition to working together, the other message we have for them is that they must understand



their customers and be aware of what is in demand on the market. With just a little support and a genuine partner, small and medium enterprises in the country can succeed because they are great companies.





SEE Capitalizing on IT & Digital Economy Trends

The digital economy is something worth investing in

Seven of the most successful global enterprises are tech companies, and five out of seven of these companies had double the GDP of the countries of Southeast Europe. Panelists noted that many companies are unprepared to undergo total digitalization, adding that they must not be ignored, but rather assisted, by raising their awareness in order to have them adopt new technologies. Panelists also discussed fantastic opportunities for investment in Bosnia and Herzegovina as the country which is closest to the EU. They also mentioned that investors in the country will find great potential in Bosnian universities and among educated people.

The Panel moderator was Mr. Armin Talić, Bit Alliance, Sarajevo, Bosnia and Herzegovina.

Mr. Branislav Vujović, New Frontier Group Vienna, Austria

The beginning of the revolution

We are now at the very beginning of the digital revolution. What we have seen so far is nothing compared to what is coming. We have to understand that this is a completely different and emerging type of economy, and understanding that is crucial. We help companies understand what is happening. Some companies in the



region managed to gain access to foreign markets, despite starting their operations in a small market. ■

Mr. Armin Osmančević, CEO, MyBazar Global Ltd. Dubai, UAE

Business development is lacking

There is a large number of talented young people in the Bosnian IT industry and the region, but business development is lacking. How do you make yourself noticeable on the business scene? We can summarize it in three points: first, create benefits in everything you do. If you innovate, you need innovation based on needs. Second, you need to strive to design



services so as to become a market leader, not a follower. Third, focus on creating ecosystems instead of acting as a person or a company that tries to achieve something alone.

Mr. Admir Kulin, CEO, m.Doc GmbH, Köln, Germany

Ideal area for investments

Why invest in this region? Because we have really great people here, and throughout history we have shown that this area produces educated people who want to work. That's why I think that this is an ideal market for investments. We cannot compete with India in terms of population numbers, but we can definitely compete on quality. We have



quality, and I am convinced that in terms of quality, we can compete with anyone in the world. Investing in this region is great because the EU is so close to us.

Mr. Dejan Miklavčić, COO, Monri Group, Bosnia and Herzegovina

Adopt new technologies

Large companies often lack the mentality for transformation. Many large companies are not ready to go fully digital, except for companies that have been digitalized since their inception. We should not neglect other large companies that need to raise their awareness and change their work processes before they are ready to adopt new technologies.

Dubai as a Model of Economic Development for Other Regions

New opportunities should be seized, not waited upon

The Panel moderator was Dr. Harun Kapetanović, Economic Advisor, Dubai Government, while the panelists were Mr. Mohammad Ali Al Kamali, Deputy CEO of Dubai Exports in the UAE and Vice President of Arab Union for Industrial Exports Development in Egypt, and Dr. Ashraf Ali Mahate, Chief Economist of Dubai Exports.

During this panel session, the participants talked about ways the economy works for the private sector to earn extra money. The focus was on Dubai and what Dubai could give to the region. In addition, a great deal of attention was focused on the Google era, and, as emphasized by the participants, its importance in creating partnerships and understanding the culture of the people establishing these partnerships to build a good relationship for each success. Dubai, its organization and hardware, without which there is no successful business, was taken as an example of an excellent model for economic development.

Mr. Mohammad Ali Al Kamali, Deputy CEO, Dubai Exports, UAE

Focus on methodology and working with the rest of world



We must not waste time but rather seize an opportunity, add value, and create a plan. We must create every opportunity for our companies to grow. Also, it is necessary to focus on methodology and working with the rest of world. Our hotels offer high-end services. This is an important thing, and our goal is to make Dubai even more advanced. We have presented six new ideas that will be implemented in the next 24 months. I'm talking about creating a strategy, and you need to see how and in what manner you can work with us and see how products from Dubai can find their way here. The government should not expect someone to change it; rather, it changes itself. Most countries think that the biggest barrier is to do business in another country. We have eliminated these barriers, and that is why we now serve as an example to everyone.

Dr. Ashraf Ali Mahate, Chief Economist, Dubai Exports Our economy is smart



Dubai creates opportunities; we do not seek them, and we are not waiting for them. We act in a logical manner and use a strategy that saves us millions in the process and makes the economy competitive. We are trying to create an economy that will be relevant in the future. Our economy is smart, and hardware is very important for a good life. Dubai is an excellent example of how to make the strongest hardware, and government should make this possible and create opportunities for building and construction. This is what is fantastic and what creates business. For example, we were the

first to promote an Islamic tourist financing service, and these are halal services. Such a creative economy works quickly, establishes connections and provides opportunities for young people. The creative industry is the industry of tomorrow. Relations, networks and political will are the most important things, because partnerships and technologies are short-lived today.



H.E. Igor Crnadak, Minister, Ministry of Foreign Affairs, Bosnia and Herzegovina

We have to make the diaspora feel welcome and safe

I am pleased to see that this is the most successful Forum so far. Year after year, we provide organizational and technical assistance to make it even better, and I'm convinced that the 10th jubilee edition of the Forum will be a real spectacle. It is very important to send several messages: Bosnia and Herzegovina is a country where people expected to live better than

they actually do 23 years after the war. Most citizens in Sarajevo, Mostar and Banja Luka expected more jobs, higher wages and better existential security. 
the war, and some of them during or after the war, should be provided with a specific atmosphere and signals by us, not just that they are welcome but that they are wanted here and that we need them even more.

to establish those contacts, i.e. reach the people we need. My instruction from the beginning was to avoid distinguishing between all of our people who have succeeded in the world. The only thing that can help us is to jointly work out how to create a better life here because the crux of the matter is that we should attract people based on mutual trust, better internal understanding and greater respect among ourselves in Bosnia and Herzegovina.

The real sector has shown interest in



First of all, it is important to know how to draw the attention of the world to what this country can offer. What I'm interested in is how creative Bosnia and Herzegovina can be in attracting attention. People are fascinated by those who are able to bring new products to the market, which can change established habits.

How and in what way can Bosnians prepare the ground and turn the mere interest exhibited by foreigners into an investment? Businesses are wondering what benefits they will have from their investment. To what degree Bosnia and Herzegovina can be truly dedicated to turning interest into a concrete investment? About 30 US companies invested here, mostly in Sarajevo. This tells me that real sector investors have an interest in investing here, that people really turn their interests into commitment, investments, jobs and benefits. The US government saw this. I now ask the question, how to draw attention and commit ourselves to reforms that will bring us real investments?

H.E. Şekib Avdagiç, President of İTO, TOBB Representative, Turkey

Create a diaspora base

Perhaps we Bosniaks who live in Turkey are the only ones who do not feel like diaspora. We do not have a database on our diaspora, we look for one person at a time. And if there are some platforms in other countries, we are not aware of them. We cannot see the whole picture when it comes to our diaspora, so we cannot develop a sort of policy for dealing with our diaspora. Turkey loves Bosnia, Bosnia loves Turkey, but a businessman is looking at what is real on paper. BiH has municipalities, cantons, entities. In order to achieve their goal, businessmen are able to skip obstacles, especially those whose size they are aware of. Unfortunately, in BiH, these obstacles are dynamic and they vary. This drives investors away. If registering a company can take up to three months here, businessmen will lose interest.









Diaspora, Sports, Arts, Culture & Creative Industry – Transforming Emotions into Investment

Success in our country is a challenge which we must not avoid

How to bring young people back together with the businessmen from the diaspora to our country was the topic of this round table. The participants discussed the ways to use advantages offered by the diaspora. It is said that the economic potential of Bosnian diaspora is the topic that is often mentioned in the public,

yet BiH continues to face many obstacles that stand in the way of this cooperation. It is also stated that there is no comprehensive database about where Bosnian diaspora is located, which all comes down to smaller individual platforms in some cities.






H.E. Đemila Talić Gabriel, Honorary Consul of Bosnia and Herzegovina in New South Wales, Australia

I faced many administrative obstacles, which is why I had to invest more than I would have needed in Sweden. It's a difficult country to succeed in, but it's our country. My message is that, if you are an entrepreneur, you will have to leave your comfort zone and take a risk.

The point of investment is not just getting money. In addition, you, as people from other countries, should learn about technology, skills and the way to establish an open market in your country. See how advanced China is. They have



Sarajevo Business Forum, the largest business and investment conference in Southeastern Europe, was held on April 25 and 26 2018 in Sarajevo, and it has attracted great interest from the media and the public. A record number of journalists reported from the conference for which 371 media representatives were accredited, up by 15% compared to the last year.

The Forum was preceded by a series of activities aimed at stimulating the interest of target groups from BiH and the region for accreditation and participation in the Forum, as well as at increasing the interest of the same media for covering preparatory activities and organization of the Forum.

Based on the Medaitoolkit survey (Internet data: web, Youtube, Twitter, Facebook) from 1/2/2018-25/5/2018, Sarajevo Business Forum was mentioned on 2.344 occasions.

Out of that number, it received the highest coverage as a web keyword, i.e. in online media. The largest number of reports was registered on the first day of the SBF, a total of 517. Among online media that reported on Sarajevo Business Forum most frequently were Fena, klix.ba, n1info.com, biznisinfo, Poslovne novine portal and Anadolia.
