MAIN PRIORITIES ARE EU **INTEGRATIONS AND FAST GROWTH**

We need to work on those things that will bring us closer towards integrations



arajevo Business Forum is a good opportunity to encourage building relationships that will enhance development. BiH is a complex country, consisting of two entities and three constitutive

people. Admittedly, it is difficult for the political functioning; however, it is a stable country for business and Bosnia and Herzegovina is a place for safe investments.

Our main priority are EU integrations. One of the major agreements reached so far relate to the idea of bringing Bosnia and Herzegovina closer to the EU. We need to work on those things that will bring us closer towards integration. This does not mean we are not open

for cooperation with other countries, of course. We will continue cooperation with other countries, such as Turkey, Malaysia, Morocco, China, Russia etc. We have proven to be stable partners for investments from China, but have also a good cooperation with Russia when it comes to the energy sector.

BiH is a stable country for business, and the time behind is the best proof for this. In Bosnia you may safely invest and develop your business with

confidence. Other major priorities are security, safety and development.

BiH has left behind itself the time when it needed

humanitarian aid and help in terms of reconstruction. Today, we need the support in terms of development. However, the development should be

in mutual interest. We are aware of the fact that only fast growth may divert the country from any kind of destabilizations.

The biggest destabilization that is currently distracting us are young educated people leaving the country. In order to prevent this, we must create a sustainable economic system. Bosnia and Herzegovina is not

a place suitable for cheap labour. Remaining within the sphere of humanitarian aid is no longer a priority of Bosnia, nor it is in our interest. We are a country with highly educated and emancipated working force that is competent to offer skills required by big companies.

There is a good atmosphere for cooperation here and I wish you success in business contacts that you will accomplish here, hoping that what you achieve will be of long-lasting endurance.

STATEMENTS, H.E. BORUT PAHOR, President of Slovenia THE FUTURE OF BOSNIA AND **HERZEGOVINA IS CLOSELY CONNECTED WITH ACCESSION TO THE EUROPEAN UNION**

EU enlargement is feasible and needs to be faster

/e debated the future of this country with the Presidency of Bosnia and Herzegovina. I am particularly thankful on the debate on one important issue: I believe that the safe and successful future of Bosnia and Herzegovina is closely connected to the accession to the European Union and I am speaking here as one leader of one of the 27 countries that are full members of the EU.

The enlargement policy of the European Union in the future in the next couple of years should be more flexible - in a political sense, and less technical. There is no consensus on this within the EU, but there should be. When the new European Commission is formed after the elections, one of the first questions will be the speed of the enlargement process and according to my opinion it needs to be faster. I am not saying that standards like the Acquis should be lower. Politically speaking, it is the time now for the European Commission to see Western Balkans as a geopolitical question, and the enlargement of this area as a geopolitical topic. It is not just a technical question of negotiation between the Commission and each country.While consolidation of the European Union should be the top priority in the years ahead, the enlargement process of the Western Balkans should not be neglected or delayed but treated as a geopolitical subject. On the other hand, it is up to the governments in the region to do their job and to do it fast, while it is up to the Commission and the European Union to consider if they can speed up the process of enlargement towards Western Balkans. The delay of this topic could jeopardise the whole process and the security in this part of Europe. It is up to the government of Bosnia, Kosovo, Albania, Serbia and Macedonia to speed up reforms, not waiting for the EU. At the same time, I wish so deeply for the EU to be capable to reach consensus and to see the enlargement process towards Western Balkans as the absorption process towards this region is feasible.

Whatever happens, my country will try to be the friend of this country and this region in its best capacities. I can speak on behalf of my country: we will do our best to convince our friends in the EU to think about this important crossroad as far as Western Balkans is concerned. If we neglect, out-fashioned nationalistic political forces will come up and try to change borders with ethnical prints which will jeopardise the security of the European Union.

I am proud about the trilateral process between Turkey, Serbia and BiH back in 2010, whereby the psychology changed. The future belongs to us, and will be specified by us. If we develop a forward -looking vision we will create a bright future for all generations.

Talented and educated people are leaving because they are attracted to life in large and well-organized cities, higher salaries and various forms of intangible appreciation. Importing talented staff from poor countries should be considered as intellectual property, and should require fees payments to the countries that created them. This is not a systematic solution, but these fees could be invested in financing the "brain-gain" policy.

The outflow of professionals is currently experienced by many developing countries. In Malaysia, we are creating an environment, facilities and incentives to reverse the brain drain to brain gain. We have a Returning Expert Program – we are giving 15% tax incentive, tax exemptions for families of those that are returning. Specific programs for women entrepreneurs through financial institutions have been developed as well, alongside other policies to further job creators.

Young people need to look for inspiration and creativity at the beginning of their careers. Cooperation amongst countries is developed through international organisations to enhance development. Youth cooperation plays a key role in these processes. It is important to strengthen the perception that success of young people is possible for those who stay here. We have to put additional efforts to promote creative policies and cooperation thorough regional recognition of academic degrees, and removing business barriers.

MR. SVEN PETKE, Director, Konrad Adenauer Foundation, Bosnia and Herzegovina / Former Member of Brandenburg State Parliament, Germany

At the end of 2018, 10.9 mil foreign nationals were registered in Germany, among them 266 thousand people outside the EU, growing by 20% for the third year in a row. Albania, Bosnia and Herzegovina, Serbia, Montenegro, Macedonia made 25% of all proposals for resident permits for employment in 2018. In 2013 Kosovo launched a campaign entitled "you are part of homeland", which gave 400.000 diaspora members an important message. This was an important first step in tackling the issue. Governments need to establish better communication between diaspora, but also introduce good economic and other incentives.

MR. REŠAD ZAČINA, Co-Founder & Executive Director, Ministry of Programming, Bosnia and Herzegovina

Being influenced by media I decided to leave for Sweden where I worked for the 3rd out of 50 best ranked companies in Europe, learned how to lead and bring people from other countries and replicated the same model in Bosnia. We built the BIT Alliance which assembles 60 of the biggest companies with thousands of employees. After three and a half years of operations we made 2 million profit. We had no support from the government, but we had people. People from this region are extremely talented, brave and they are empowering. We just need to build a better business environment to operate better and employ people under more favorable terms.

MR. UMUT ERGEZER, Director for Aid Effectiveness and International Cooperation, Economic Policy Research Foundation (TEPAV), Republic of Turkey

We often apply the natural law of gravity in economics. This is what is happening in the Balkans. This big economy is the EU; and small economies are Western Balkans countries so regional economies are diverted to the EU. When you sign a free trade agreement with the bigger economy, the trade is steadily being diverted to the EU. There is often a perception that EU accession accelerates the economic growth, which has empirically not been proven. The key is to develop policies required to strengthen economies of this region to enable transfer of skills and knowledge.

MR. GJERGJ MURRA, Executive Director, Western Balkans Fund, Albania

The Western Balkans Fund (WBF) is a new model and opportunity in the region. There are around 45.000 civil society organizations in the Western Balkans, trying to influence the governments and hold them accountable. WBF was a first organization created by the governments of the Western Balkans to support civil society projects and initiatives in the region. You can't fight brain-drain without devoting more resources to the civil society sector. The Youth Agenda needs also to strengthen. Links between quality education and the needs of the private sectors need to be improved by enhancing innovation. The business sector also needs to take action to achieve all this.

For investments, it is very important to see if there is adequate human talent

see more opportunities than challenges. If you think there are challenges in the world, then you are not going to set foot outside your house. There is no region or no single continent that is lucrative

to do business from a businessman's perspective.

So, you really need to have courage to go into new geographies. You need also to see the bigger picture. For investments, it is very important to see if there is adequate human talent, because sitting from Dubai you cannot operate institutions in Indonesia, Africa, Bosnia or Pakistan via remote control. The very essence of globalization lays in cultural diversity. Dubai is a classic example of globalization.

It is successful because of its cultural diversity. Globalization and cultural diversity go hand by hand. If you are not humble enough you will not be able to survive. It is easy to go and sit on the top of a pyramid but it's very difficult to stay there. I

think humility and modesty make people more successful day by day. Obviously,

more successful day by day. Obviously, as a leader you need to have vision, you need to make sure that there is no clutter in your head, you have to understand end game and you need to understand the destination. you need to inspire everybody who works for you. If you do not inspire people every day, your organization will fail and you cannot be called a leader. I think that leader is only called a leader because of a team he represents.

Being snobbish is a disease. You got to be on earth! Never challenge gravity because everything what is on top will come down one day. It's very important for people to understand that you need to be humble, you need to be honest, you need to have vision and inspire your people day in, day out.

OPERA AT THE SARAJEVO NATIONAL THEATRE



fter the welcome reception at the Sarajevo City Hall, SBF marked its 10th anniversary with a special cultural programme at the Sarajevo National Theatre. The National Theatre is one of the most important national monuments of Bosnia and Herzegovina, that is also on the list of Protected National Monuments of BiH. Built during the Austro-Hungarian period according to designs made by the architect Karl Paržik, it served as a social facility which officially opened on



January 2, 1899. With the founding of the National Theater on November 17, 1919, the building underwent a thorough reconstruction and the first performances staged in the building that exists today, took place October 1921. The National Theatre hosted the opera La bohème, composed by Giacomo Puccini to an Italian libretto by Luigi Illica and Giuseppe Giacosa, based on Scènes de la vie de bohème by Henri Murger, that has been performed for the first time in 1896.

If you invest here you cannot lose your money despite the 4th Industrial Revolution. I don't know any single investor who lost his capital investing in Bosnia and Herzegovina.



MS. ANA LUCIA LIND, Chairman & CEO, Swiss Financial Engineering AG, Switzerland

Artificial intelligence will be our extension and our complement to the world. But we cannot rely 100 % on AI. It is going to have an impact onto the whole world both, in a positive and in a negative way. We should accept our own awareness about it and we should not overprice it.

MS. LADA BUŠEVAC, Senior Country Officer, International Finance Corporation (IFC), World Bank Group, Bosnia and Herzegovina The financial industry plays a big role in the 4th Industrial Revolution. Allowing all members of the society full and transparent access to financial means is very important and this is the path for digital transformation - to enable people to get out of poverty.

BENEFITING FROM THE WOOD & FURNITURE INDUSTRY DEVELOPMENT

he wood industry is the oldest industrial branch in Bosnia and Herzegovina. Forrests make up more than 60% of the BiH area. The wood industry is mostly based on private enterprises in BiH and majority of them are export-oriented. MR. ZLATAN FAIK UZUNOVIĆ,

Managing Director, Prevent Interior, Prevent Group, Bosnia and Herzegovina

Furniture products are not made from the wood exclusively, but other materials such as textile and leather as well. What Prevent Group did is expertise in full furniture production with all its ingredients and we aim to become one of the main suppliers for IKEA. We believe that the future of the furniture business is not in retail, but online sales.



MR. NEBI HOXHA, President, Economic Chamber of North-West Macedonia, Republic of North Macedonia

The main issue for regional producers is price competitiveness with the competition from Asia and other countries. The second issue is the lack of well educated, qualified, and well experienced workforce to other EU countries.

MR. ZORAN VUKOVIĆ, Executive Director, Institution of Vocational Education and Adult Training - WMTA, Bosnia and Herzegovina

The most important steps for BiH companies in becoming competitive on larger markets within the wood industry are the digitalization of the processes and constant education of people.



MR. AMIR ĆORALIĆ, Board Member, Swedish Chamber of Commerce for B&H, Bosnia and Herzegovina

The B&H furniture industry is the best in the region at this moment. Many furniture companies had transition periods and are well digitalized. Our products are well recognized in Sweden and the rest of the Europe as well. Through the Swedish Chamber of Commerce, we are working on the establishment of a hub to ease the process of exporting, logistics, and strengthen the market position for B&H furniture companies in Sweden.

Few elements are crucial when we talk about connecting. There is a physical connection. Currently between two countries there is no direct connection, either we have to go over Istanbul or Doha. It also reflects on trade, Bosnia has a lot of products that can be exported to Malaysia, but it is very expensive. Both countries must work on "people to people" connection. Finally, both countries must work on mutual marketing and promotion to enhance tourism.



MR. CHRIS GABRIEL, CEO, FlyBosnia, Bosnia and Herzegovina

WHETHER WE CAN HAVE DIRECT LINKAGE FROM SARAJEVO TO KUALA LUMPUR – ANYTHING IS POSSIBLE. THERE ONLY NEEDS TO BE A WILL.

Not only direct flights but also internal agreements with Malaysian airlines, couching and trainings. The catalyst of success is to work jointly together between a mix of Malaysian and Bosnian skills.



MR. VEDAD HALILO Herzegovina

Recently AS Holdings representatives have visited Malaysia twice; the first visit was by our CEO to the Prime Minister of Malaysia YAB Tun Dr. Mahathir Mohamad, while the second was the AS Holdings team's visit to Malaysian International Halal Showcase (MIHAS). As an outcome, AS Holdings is now expecting to expand its relationship by exporting goods to Malaysia, while at the same time we will import palm oil from Malaysia.

INVESTMENT ROUNDTABLE REGIONAL PLATFORM FOR ATTRACTING INTERNATIONAL INVESTORS

he participants of the "Investment" roundtable have discussed market regulations and opportunities pertaining to the region, segments that attract most investments and why, as well as short, medium and long term views of investors' perspective in the region. In conclusion, speakers agreed that opportunities for investment are very present in Bosnia and Herzegovina and region, and that there is a need for synergy in enhancing cooperation on regional level, regional exchange of information about investors and passion to take "charge" in the investment world.

MR. HEDI MEJAI, Director, Investments Department, Islamic Development Bank, Kingdom of Saudi Arabia

As investor, IDB has seen a future of the region back in year 2000. Our first investment was the establishment of Bosna Bank International. Therefore, we created firstly a financial platform, BBI, to channel FDI into the country. Then we built a market place, BBI Center, which created a momentum in Sarajevo and the region. Finally, we supported SBF, because we felt it is important to have a marketing platform to change investor perception.





MR. GORDAN MILINIĆ, Director, Foreign Investment Promotion Agency (FIPA), Bosnia and Herzegovina

FIPA, BiH embassies and leaders are trying to explain to foreign investors that we are a safe country. We are also explaining to investors that Bosnia has many comparative advantages for investors such as a stable financial sector, geographical location, favorable trade agreements, favorable tax and custom rates, availability of skilled and educated labor force and attractive investment locations.

MR. CHRIS GABRIEL, CEO, FlyBosnia, Bosnia and Herzegovina

The smartest thing that Bosnia and the region can do is to grab some investors, people that have gone abroad and lived in different places before, then put together an advisory board that thinks in a different way compared to historical viewpoints. Get some passion into that process and recipients will hear it, deliver and back it up. We must not focus on why we cannot, but instead how we can.





MS. FATMA CINAR, Head of International Banking, Kuveyt Turk Participation Bank, Republic of Turkey

UN mentioned that for sustainable development goals worldwide we need four trillion dollars for investment while it currently amounts to 1.4 billion dollars. So we have a huge gap in investments to attract to our countries. Banks are the most solid and credible institutions of the countries, but also the frontline, the touchpoint to investors and they need to be visible. SBF itself is best place to practice conversation with investors.

MR. MAHO TASO, Director, Prostor, Bosnia and Herzegovina

I can say that my biggest achievement so far is returning to Bosnia after living abroad, and this is what our vision should be. We should not stop our young people to go abroad, we need to encourage them to go out and get new knowledge, new energy, and then attract them to come back and build a country. Finally, we should be the bridge between East and West as well outsourcing arena.



MS. ELDINA MUFTIĆ, Vice President, ZERAA Agriculture Investment & Management, Bosnia and Herzegovina

Most investors who come to our country are attracted to the geographic position, national resources, climate, and availability of labor. ZERAA invested in two companies close to KM 60 million, infrastructure, equipment, systems, and plantations and are already in the EU market. We need local community support and new investors.

MS. VEDRANA LIKAN, Managing Partner, Colliers International, Croatia

It is not easy to present the region because it is full of variety and this is where attraction lies. My highlight, when it comes to region, is "a lot of opportunities", with emphasis on partnership with local people, being innovative and creative, and this is where the strengths come from.



AG, Switzerland

As investor you can only access the market when leadership works. When leadership is your marketing, everything flows. Secondly, be a voluntary ambassador of your country, meet people. It is not about what you can spend and how you spend it, it is how you link with people who accept you.

MR. HASAN ŠEHOVIĆ, President, World Diaspora Association of BiH

2 million people from Bosnia live abroad and it is thought that those people are lost for the country. But actually this is a strong Bosnian force which is living abroad. Many Bosnian people who live abroad are playing prominent roles, such as ministers, CEOs, doctors, engineers. We must make one network to introduce all of these people to think about Bosnia and create a system which will assist diaspora, including laws that will help diaspora.



MR. DRAGI DIZDAR, Board Member, Pragma Group, Norway

The best investment in Bosnia is long-term cooperation which makes a win - win situation for Bosnia and diaspora. Our strongest force is 2 million diasporas worldwide. I believe we should invest in the identity of the Bosnian diaspora and this will result in additional investment in our country.
